# **About PGP**

The Post Graduate Programme in Management programme at the Indian Institute of Management Rohtak (IIM-R) offers a judicious blend of theory and practice and is delicately designed to be change-oriented. The course curriculum is continually reviewed and updated to cater to the requirements of the industry and reflect changes in the environment. A unique feature of the IIM-R PGP is its in-built concern for the larger society, as reflected in the design of the curriculum, which aims at nurturing well-focused, value-conscious and socially committed managers and leaders of the future. Beingaware of the shifting boundaries and the winds of change in a globalizing business environment, program also lays considerable emphasis on exposure to many aspects of international business and related strategic and cross-cultural issues.

The first year of the programme provides the incoming students with a through grounding in the functional areas of Management. Rural Engagement Program (REP) is a mandatory program that takes place immediately after the end-term exams of Term – I. It is a course having a credit of 0.5. The summer internship is an important building block of the programme. The second-year courses, apart from 3 simulation-based compulsory courses one in each term, are elective offerings in the areas of *Economics and Public Policy, Finance and Accounting, Management Information Systems, Operation, OB & Human Resource Management, and Marketing & Strategy.* IIM-R Faculty, as well as professionals from industry and academia (as adjunct and guest faculty), conduct these courses, which give in-depth insights into the subject matter, and hands-on experience through projects and diverse case studies.

Passing the Communication Workshop Courses in PGP 1<sup>st</sup> year is compulsory. Any student who secures 'F'grade in these courses, will not be allowed to attend the placement process.







# **Program Structure:**

The duration of the IIM-R Post Graduate Programme in Management is two academic years. Each academic year normally begins in June/July and ends in March and consists of three Terms. The students go for summer internships at the end of the third Term for a period of about 2 months. (April 1<sup>st</sup> week to June 1<sup>st</sup> week)

Each *Course* in the IIM-R PGP programs structured around the concept of *credits*. Each creditrepresents 25 hours of contact sessions. Students should note that 25 hours of instruction will normally require another 75 hours of preparation on their own at the minimum; so, typically at least 100 hours need to be devoted to a 1 credit course.

Instructors choose from multiple pedagogical tools including lecture discussions, case methods, behavioural and computer-based simulations, projects, class presentations, and various forms of technology-based learning such as multi-media, case analysis, video conferencing, and e-learning, to facilitate effective learning in their courses.

### **FIRST YEAR - Compulsory Courses**

The **first-year courses** are aimed at building the foundation of the program. Hence, all students are required to complete all the first-year courses. These courses are designed to provide basic conceptual knowledge and analytical tools in different disciplines and functional areas of management incorporating interdependent and inter-related disciplines, functions, and factors that form the core of organizational functioning and managerial effectiveness. Uniquely, the first-year curriculum also consists of courses that aim at inculcating a sense of ethical consciousness and social responsibility.

# **SECOND YEAR - Elective Courses**

In the **second year** of the program, students register for **elective courses** which are, courses of their choice, from a large set of courses offered by various *Academic Areas* of the Institute. They also take one simulation-based compulsory course during Term IV, V and VI respectively. The term-wise list of core courses each of One (1) credit is given below:

Term – IV: Global Business Simulation (GBS)

Term - V: Markstrat Simulation (MSS)

Term VI: Capstone Simulation (CS)

The elective courses are expected to enable a student to gain deeper knowledge and understanding of and acquire the required skills in specific/chosen areas in management.

For the second year of the PGP program, students have to take term-wise elective courses of their choice fulfilling the below credit requirements (Excluding Core Courses).

# **Integrative Project:**

As a completion requirement of the two years MBA program, students are assigned to do an "Integrative Project" in Term VI.



# Admission Process for PGP 2025-27 (Batch-XVI)

This document details the process for selecting candidates for the PGP programme at IIM Rohtak for the PGP 2025-27 (Batch-XVI). The basic objective of IIM Rohtak's admission process is to identify meritorious candidates for admission under each category of admission. While merit is the prime consideration, the Institute recognizes possibility of skewed student structure in favour of male gender and engineering and related subjects graduation in the normal course. Hence, it strives to ensure a better balance in opportunities among different subject streams and genders. It is also part of IIM Rohtak's approach to duly recognize academic and gender diversity.

The admission process of IIM Rohtak is a five-stage process:

- **Stage I** Online Registration for PGP Admission 2025-27 (Batch-XVI), IIM Rohtak.
- **Stage II** Personal Interview (PI) for only shortlisted candidates.
- Stage III The Final Selection List based on CAT score, PI score, Gender and Academic diversity.
- Stage IV Offer for Provisional Admission for the PGP programme 2025-27 (Batch-XVI).
- **Stage V** Reporting for joining the PGP programme 2025-27 (Batch-XVI).

# Stage I- Online Registration for PGP Admission 2025-27 (Batch-XVI), IIM Rohtak.

- 1. Minimum eligibility criteria for registration process are based on the aggregate percentile scores in the CAT 2024 as mentioned in Table 1 below:
  - \*Meeting minimum eligibility criteria does not ensure that the candidate is shortlisted for the Personal Interview (PI) Process.

- 2. IIM Rohtak will invite online applications for registration in PGP 2025-27 (Batch-XVI)
  - a.) Registration will start from December 21, 2024 and the last date for online registration will be January 03, 2025 (11:59 PM).
  - b.) Candidates need to create their Login ID (USER NAME & PASSWORD) for online registration. Candidates need to submit an application/admission data form along with a non-refundable registration fee of INR 3095 (Three thousand ninety-five only).
- 3. Eligible candidates will receive an Email with a web-link for registration for the PI process for PGP Admissions 2025-27 (PGP Batch XVI).
- 4. The shortlisted candidates who have submitted the application form and registration fees by the stipulated date and time, will be considered for subsequent stages of the admission process (Stage II and onwards).

## **Stage II- Personal Interview (PI)**

- 1. All shortlisted candidates at Stage I will appear in Stage II i.e. Personal Interview.
- 2. All the shortlisted candidates will be informed by Email to download their call letters to appear in the Personal Interview. All the required details, like date, time and other required guidelines, will be mentioned in the call letter

# Stage III - The Final Selection List based on CAT, Personal Interview & Diversity scores.

- 1. A weight of 60% will be assigned to the CAT Total Score (Scaled to 100). A weight of 20% will be given to the Personal Interview Score. Further, a weightage of 20% will be given to Academic diversity and Gender diversity.
- 2. The weighted aggregate of the following components, namely (a) CAT, (b) Personal Interview, and (c) Diversity, will be used to prepare a merit/rank list, and accordingly, the candidates will be communicated about Stage-IV of the admission process.

# Stage IV – Offer for Provisional Admission for the PGP programme 2025-27 (Batch-XVI).

- 1. The offer of admission to the candidate will be made strictly on the basis of merit/ rank list and availability of seats in each category (General, EWS, NC-OBC, SC, ST & DAP) as per reservation rules of Govt. of India.
- 2. All the shortlisted candidates will receive a provisional offer letter for admission from <a href="mailto:pgpadmission@iimrohtak.ac.in">pgpadmission@iimrohtak.ac.in</a> on their registered Email ID.
- 3. A candidate receiving an admission offer from IIM Rohtak (IIM-R) and accepting the offer within the stipulated date needs to deposit the Offer Acceptance Amount (as mentioned in the Offer Letter) through the admission portal only. An automated receipt and a text message of the transaction will be shared by the associated bank on the registered Email ID/ mobile no. of the candidate
- 4. The candidate will receive his/her confirmation letter for provisional admission for PGP Admission 2025-27 (Batch-XVI) on his/her registered Email ID. All the reporting requirements/ joining formalities will be mentioned in this confirmation letter (i.e. date, time, venue for joining, last date to deposit the full term fee, fee structure, affidavits from the student & the parents, Indemnity Bond, vaccination certificate, updated category and income certificate (if applicable), Govt. Photo ID, medical fitness certificate, application form for hostel allocation, a schedule for classes etc.).

# Stage V – Reporting for joining the PGP programme 2025-27 (Batch –XVI)

- 1. The candidate needs to login on to the Institute website by using his/her login credentials (Username and password) to deposit the fee (Term Fee & Mess Fee) as mentioned in the offer letter within the stipulated date and need to report to the Institute as communicated schedule in the joining instructions letter.
- 2. Further, on the day of reporting on the campus, the admission team will physically verify the documents and allocate hostel rooms to the candidates. Hostel allocation (Twin sharing A.C. Rooms) will be done on a first-come, first serve basis separately for male and female students. Hostel rooms for the DAP category will be arranged on the ground floor on a twin-sharing basis (preferably).

# Refund Policy (PGP 2025-27) (Batch -XVI)

The last Date for any withdrawal of provisional admission will be 'On or before the date of Registration' (online/ on campus, as the case may be). The entire fees received from the student, after deduction of the processing fee of Rs. 1000/- (one thousand only), will be refunded to the candidate by the mode of bank transfer to the candidate's own savings bank account provided by the candidate. The refund requests will be accepted only through the institute's admission portal, i.e. <a href="https://admission.iimrohtak.ac.in/SignIn/pgp-2025-27">https://admission.iimrohtak.ac.in/SignIn/pgp-2025-27</a>

Refunds will be made automatically within 150-180 days from the date of registration of the program.
