#### ***About IIM Rohtak***

Indian Institute of Management Rohtak, established under the aegis of the Ministry of Education, Government of India, is an institute of national importance. Indian Institute of Management Rohtak (IIM Rohtak) is a benchmark for top management education in India, with a vision to become a global leader in due course. The Institute has an enlightened and progressive leadership, acclaimed faculty members, extensive infrastructure, and robust teaching pedagogy in place. Located within the National Capital Region (NCR) of India, the permanent campus of IIM Rohtak is 75 minutes from Delhi International Airport. The state-of-the-art campus, spread over an area of 200 acres, is strategically located on National Highway - 09, and is well connected to Delhi.

IIM Rohtak has been ranked 19<sup>th</sup> in the country on educational ranking. The Institute offers a dynamic environment for high-quality research in all functional areas of management that will benefit various segments of the business and society.

#### ***About IPM Programme***

IIM Rohtak introduced the Five-Year Integrated Programme in Management (IPM) in the year 2019 for students after class XII who aim to pursue their career in Business Management. It is an integrated programme that combines undergraduate (UG) and postgraduate (PG) courses on management. The IPM programme aims at molding outstanding young students into managers and leaders. On successful completion of the academic rigor of 5 years, the participant will be awarded with Integrated Degree of BBA, + MBA.

#### ***Programme Structure & Curriculum***

Overall, the programme consists of 15 terms spread over a period of 5 years. A year has three terms, each of roughly 3 months duration. The entire programme is divided into two parts; the first part focuses on the foundation courses, whereas the second part focuses on management. Students will be undergoing several internships during the course of the programme.

The first part has four core areas: Mathematics, Economics, Statistics, and Humanities. Apart from these, other courses such as Business Communication, Management Information System, Business, and Foreign Languages are also offered. Courses offered at the PG level (4th and 5th Year) will be the same as the PGP curriculum focusing on management.

The students will have to maintain a minimum CGPA of 5.0 at the end of third year to be eligible for the last two years of the programme to earn a master's degree. Students below 5.0, but not less than 4.0 CGPA will be awarded a BBA degree and will exit the programme. Also, if any student voluntarily intends to exit the programme after successfully completing the programme requirement at the end of 3 years, he/she will be awarded a degree of Bachelor of Business Administration (BBA) on notifying the office about the exit within the stipulated time in the third year of the Programme.

### **Eligibility Criteria:**

Candidates must satisfy the following criteria to apply for this programme.

- (i) Minimum 60% (55 % for SC, ST & DAP) in standard X/ SSC and standard XII/ HSC or equivalent examinations.
- (ii) Maximum 20 years (*25 years for SC & ST category*) of age as of **June 30, 2026**

**Note 1:** Candidates who are likely to complete standard XII/ HSC or equivalent by the end of **June 2026** can also apply, subject to meeting the minimum eligibility criteria after the declaration of results (only in case of XIIth standard) as mentioned above. If selected, such candidates will be offered provisional admission to the programme. At the time of registration for the programme, such candidates must produce X and XII standard mark sheets (securing minimum marks, i.e. 60% for General, EWS, and NC-OBC or 55% for SC, ST, and DAP) along with school leaving certificate/migration certificate, failing which the candidate's admission offer stands cancelled.

**Note 2:** The percentage of marks obtained by the candidate in X and XII Standards would be calculated based on the *aggregate marks of any best five subjects that appear in the mark sheet/grade sheet, irrespective of the Board's regulation*. In case the candidates are awarded letter grades or grade points instead of marks, the conversion of grades to the percentage of marks of any best five subjects would be based on the procedure certified by the Board/ Competent Authority, explaining the method of conversion from where they have obtained the certificate.

### **Selection Procedure:**

#### **Stage I: Online Registration for IPM Batch 08 (Session 2026-31), IIM Rohtak.**

- (i) Interested applicants who fulfil the above-mentioned eligibility criteria are required to fill out the registration form that aims at evaluating the applicant's proficiency in academics as well as in extra-curricular activities.
- (ii) The eligible applicants will pay a *non-refundable registration fee of ₹ 4,937* (Four thousand nine hundred thirty-seven only).

#### **Stage II: IPM Aptitude Test (IPM AT 2026)**

- (i) All the interested applicants will undergo IIM Rohtak's IPM Aptitude Test that will examine the aptitude, logical reasoning, and proficiency in English of the applicant.
- (ii) ***IPM AT 2026 to be conducted on May 10, 2026 (Tentative) from 9:00 AM onwards.***
- (iii) IPM Aptitude Test will comprise of following sections:

Section(s)	Number of Questions	Time Duration
Quantitative Ability	40	120 minutes
Logical Reasoning	40	
Verbal Ability	40	

**Note:** Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

- ❖ In case the candidate also selects the Integrated Programme in Law (IPL) option while registering for IPM AT 2026, such candidates will also appear for legal reasoning as following:

**Note:** Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

### **Stage III: Shortlisting and Personal Interview (PI)**

- (i) The shortlisted applicants will be called for a Personal Interview on the basis of minimum eligibility criteria and IPM AT Score 2026.
- (ii) The announcement of Call for Personal Interviews (PI) will be made by the ***end of May 2026 (Tentative)***.
- (iii) The candidates during their personal interviews will be judged on the basis of their academics, general awareness, and communication skills.
- (iv) The interviews are proposed to be held in the ***first or second week of June 2026 (Tentative)***.

### **Stage IV: Announcement of Selection List**

- (i) The Final Merit List will be generated based on the composite score of IPM AT 2026, past academics and personal interview. The final merit list for the admissions is prepared as per the weightage given below:

Component (s)	Weightage (%)
Aptitude Test Score 2026 (IPMAT)	55
Personal Interview (PI)	15
Past Academics (Xth /SSC) or Equivalent Examination	10
Past Academics (XII/HSC) or Equivalent Examination	20
<b>Total</b>	100

- (ii) The institute will tentatively announce the merit list by the ***second week of July 2026***. The offer of admission to the candidate will be made strictly on the basis of merit/ rank list and availability of seats in each category (General, EWS, NC-OBC, SC, ST & DAP) as per the reservation rules of the Government of India.

### **Stage V: Provisional Admission to IPM Batch 08 (Session 2026-31)**

- (i) All selected candidates will receive a provisional offer letter for admission from **ipmadmission@iimrohtak.ac.in** on their registered Email ID shortly after the merit list declaration. A candidate receiving an admission offer from IIM Rohtak (IIM-R) and accepting the offer within the stipulated date needs to deposit ₹ 1,00,000/- as the OAA, i.e. Offer Acceptance Amount (or as mentioned in the Offer Letter), through the institute's admission

- portal only. An automated receipt and a text message with details of the transaction will be shared by the associated bank on the registered Email ID/ mobile number of the candidate.
- (ii) On acceptance of the admission offer and payment of OAA, the candidate will receive his/her confirmation letter for provisional admission to IPM Batch 08 (Session 2026-31) on his/her registered Email ID. The paid OAA will be adjusted with the First Year Programme Fee. Such candidates will be required to pay the 1st instalment of the First Year Programme Fee (as mentioned in the confirmation letter) through the institute's admission portal only. If a candidate fails to pay the 1st instalment of First Year Programme Fees by the stipulated date mentioned in the admission confirmation letter, the seat will be cancelled.
  - (iii) The fee structure for IPM Batch 08 (Session 2026-31) is available on the institute's website.

**Stage VI: Reporting for joining the IPM Batch 08 (Session 2026-31)**

- (i) Final selected candidates who have deposited OAA and got a confirmation letter for provisional admission will be required to report physically (on the stipulated date and time) on the Institute campus for registration, followed by physical verification of educational documents and other testimonials as per the checklist (in case of online registration, the documents will be verified virtually).
- (ii) The academic session will tentatively begin in the ***third week of August 2026***.
- (iii) The hostel room allocation to the candidate will be done on a sharing basis. Hostel rooms for the DAP category candidates will be arranged on the ground floor (preferably).

**Note:**

- (i) The admission criteria for IPM Batch 08 (Session 2026-31) may be changed before the declaration of the results.
- (ii) The information in this document is applicable only for the admissions cycle IPM Batch 08 (Session 2026-31). IIM Rohtak reserves the right to change, modify or adopt any new admission process that it deems necessary at any point.
- (iii) Any dispute concerning Admission for the IPM Batch 08 (Session 2026-31) would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Rohtak only.
- (iv) You will receive all admission offers in the form of a letter duly signed by the Controller of Examinations of IIM Rohtak, sent from ***ipmadmission@iimrohtak.ac.in***. Any offer received from any other email is completely invalid and is not official. All admissions to IIM Rohtak are provisional till you have completed all formalities upon reporting to the institute.
- (v) If at any point of time it is found that the information provided by the candidate is false, incorrect, or misrepresented, the admission offer will stand cancelled.
- (vi) IIM Rohtak reserves the right to change, modify or adopt any new admissions process that it deems necessary at any point.

**Refund Policy for IPM Batch 08 (Session 2026-31)**

The last date for any withdrawal of provisional admission will be '***before the date of Registration (online)***'. The entire fees received from the student, after deduction of the processing fee of ₹ 1000/- (one thousand only), will be refunded to the candidate by the mode of bank transfer to the candidate's own savings bank account provided by the candidate. The refund requests will be accepted only through the institute's admission portal, i.e. **<https://admission.iimrohtak.ac.in/SignIn/ipm-2026-31>**.

Refunds will be made automatically within 150-180 days from the date of registration of the program. Please provide your own (i.e. candidate's) correct banking details (Beneficiary Name, Saving Bank Account Number, Bank Name, IFSC code) through the institute's admission portal, i.e. <https://admission.iimrohtak.ac.in/SignIn/ipm-2026-31>.

The institute takes no responsibility in case the banking details provided by you are erroneous. Refund request(s) received from any other mode apart from the above-mentioned institute's admission result portal will not be considered under any circumstances. ***Refund requests will not be entertained after the registration to the programme.***

**Total no. of seats:**

Total no. of seats for IPM Batch 08 (Session 2026-31) will be **198** (including 10% of the total seats will be offered to EWS (Economically Weaker Section) candidates). The offer of admission to the candidate will be made strictly based on merit/rank list and availability of seats in each category (Gen, SC, ST, NC-OBC, EWS & DAP) as per the reservation rules of the Government of India.
