About IIM Rohtak

Indian Institute of Management Rohtak, established under the aegis of the Ministry of Education, Government of India, is an institute of national importance. Indian Institute of Management Rohtak (IIM Rohtak) is a benchmark for top management education in India, with a vision to become a global leader in due course. The Institute has an enlightened and progressive leadership, acclaimed faculty members, extensive infrastructure, and robust teaching pedagogy in place. Located within the National Capital Region (NCR) of India, the permanent campus of IIM Rohtak is 75 minutes from Delhi International Airport. The state-of-the-art campus, spread over an area of 200 acres, is strategically located on National Highway - 09, and is well connected to Delhi.

IIM Rohtak has been ranked 19th in the country on educational ranking. The Institute offers a dynamic environment for high-quality research in all functional areas of management that will benefit various segments of the business and society.

About IPL Programme

IIM Rohtak introduced the Five-Year Integrated Programme in Law (B.B.A., LLB) for students after class XII in the year 2021. The interdisciplinary programme aims to provide an in-depth knowledge of business management with intricate details of law and governance. On successful completion of the academic rigor of 5 years, the participant will be awarded with Integrated Degree of BBA, + LLB. ***There shall be no lateral entry on the plea of graduation in any subject or exit by way of awarding a degree splitting the integrated programme at any intermediary stage of the programme.***

Programme Structure & Curriculum

Overall, the programme consists of 15 terms spread over a period of 5 years. A year has three terms, each of roughly three months duration. The entire programme consists of courses in Business Management and Legal Education. Students will be undergoing several internships during the course of the programme.

The programme will create an opportunity for the students to pursue legal education of global standards through a curriculum and pedagogy that best reflects the study of international law, law of corporate finance, competition law & policy, direct & indirect tax law, foreign law and domestic law. Apart from these, students will also undergo courses from the domain of Business Management, International Affairs, Humanities, Public Policy, and Foreign Languages.

Eligibility Criteria:

Candidates must satisfy the following criteria to apply for this programme.

- **General, NC-OBC and EWS Category:**

- (i) Minimum 60% in standard X/ SSC and standard XII/ HSC or equivalent examinations.
- (ii) Maximum 20 years of age as of **June 30, 2026.**

- **SC, ST and DAP Category:**

- (i) Minimum 55% in standard X/ SSC and standard XII/ HSC or equivalent examinations
- (ii) Maximum 20 years of age as of **June 30, 2026**.

Note 1: Candidates who are likely to complete standard XII/HSC or equivalent by the end of **June 2026** can also apply, subject to meeting the minimum eligibility criteria after the declaration of results (only in the case of XIIth standard) as mentioned above. If selected, such candidates will be offered provisional admission to the programme. At the time of registration for the programme, such candidates must produce X and XII standard mark sheets (securing minimum marks, i.e. 60% for General, EWS, and NC-OBC or 55% for SC, ST and DAP) along with school leaving certificate/migration certificate, failing which the candidate's admission offer stands cancelled.

Note 2: The percentage of marks obtained by the candidate in X and XII Standards would be calculated based on the aggregate marks of the best five subjects that appear in the mark sheet/grade sheet, irrespective of the Board's regulation. In case the candidates are awarded letter grades or grade points instead of marks, the conversion of grades to the percentage of marks of the best five subjects would be based on the procedure certified by the Board/Competent Authority, explaining the method of conversion from where they have obtained the certificate.

Selection Procedure:

Stage I: Online Registration

- (i) Interested applicants who fulfil the above-mentioned eligibility criteria are required to register for the IPL Batch 06 (Session 2026-31) via the registration link provided on the Institute website (**www.iimrohtak.ac.in**).
- (ii) Applicants for admission to the programme will be shortlisted on the basis of their scores in any of the following entrance examinations:
 - (a) **IPM Aptitude Test (AT) 2026:** The candidate interested in the IPL at IIM Rohtak and did not appear for CLAT 2026 can also apply for IPL by appearing for IPM AT 2026. Such candidates will have to select the option of IPL along with Integrated Programme in Management (IPM) during the registration process. These candidates will appear for 4 sections in the IPM AT 2026 (Quantitative Ability, Logical Reasoning, Verbal Ability, and **Legal Reasoning**). The eligible candidate will pay a non-refundable registration fee of **₹ 4,937** (Four thousand nine hundred thirty-seven only).
 - (b) **CLAT (Common Law Admission Test) Examination 2026:** The candidate interested in the IPL at IIM Rohtak may appear for CLAT 2026. The candidate will register on the IIM Rohtak's IPL registration portal using the CLAT Application Number. The eligible candidate will pay a non-refundable registration fee of **₹ 4,937** (Four thousand nine hundred thirty-seven only).

Stage II: Entrance Examination

1. IPM Aptitude Test (IPM AT 2026):

- (i) All the interested applicants will undergo IIM Rohtak's IPM Aptitude Test that will examine the aptitude, logical reasoning, and proficiency in English of the applicant.
- (ii) **IPM AT 2026 to be conducted on May 10, 2026 (Tentative) from 9:00 AM onwards.**
- (iii) IPM Aptitude Test will comprise of following sections:

Section-I:

Note: Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

Stage III: Shortlisting and Personal Interview

- The shortlisted applicants will be called for a Personal Interview on the basis of minimum eligibility criteria and CLAT Score 2026/ IPM AT Score 2026.
- The announcement of the Call for Personal Interviews (PI) will be made by the end of **May 2026 (Tentative)**.
- The candidates, during their personal interviews, will be evaluated on the basis of their academics, general awareness, and communication skills.
- The interviews are proposed to be held in the **first or second Week of June 2026 (Tentative)**.

Stage IV: Announcement of Selection List

- The Final Merit List will be generated based on the composite score of the entrance examination, past academics, and personal interview. The final merit list for the admissions is prepared as per the weightage given below:

Aptitude Test Score 2026 (CLAT/IPM AT)	55
Personal Interview (PI)	15
Past Academics (Xth /SSC) or Equivalent Examination	10
Past Academics (XII/HSC) or Equivalent Examination	20

- The Institute will announce the merit list by the **second week of July 2026 (Tentatively)**. The offer of admission to the candidate will be made strictly on the basis of merit/rank list and availability of seats in each category (General, EWS, NC-OBC, SC, ST & DAP) as per the reservation rules of the Government of India.

Stage V: Provisional Admission to IPL Batch 06 (Session 2026-31)

- All the selected candidates will receive a provisional offer letter for admission from ipladmission@iimrohtak.ac.in on their registered Email ID shortly after the declaration of the merit list. A candidate receiving an admission offer from IIM Rohtak (IIM-R) and accepting the offer within the stipulated date needs to deposit ₹ 1,00,000/- or as mentioned in the Offer Letter as the OAA, i.e. Offer Acceptance Amount, through the Institute's admission portal only. An automated receipt and a text message of the transaction will be shared by the associated bank on the registered Email ID/mobile number of the candidate.
- On acceptance of the admission offer and payment of OAA, the candidate will receive his/her confirmation letter for provisional admission to IPL Batch 06 (Session 2026-31) on his/her registered Email ID. The paid OAA will be adjusted with the First Year Programme Fee.

- (iii) Such candidates will be required to pay the 1st instalment of the First Year Programme Fee (as mentioned in the confirmation letter) through the Institute's admission portal only. If a candidate fails to pay the 1st instalment of First Year Programme Fees by the stipulated date mentioned in the admission confirmation letter, the seat will be cancelled.
- (iv) The fee structure for IPL Batch 06 (Session 2026-31) is available on the Institute's website.

Stage VI – Reporting for joining the IPL Batch 06 (Session 2026-31)

- (i) Final selected candidates who have deposited OAA and got a confirmation letter for provisional admission will be required to report physically (on the stipulated date and time) on the Institute campus for registration, followed by physical verification of educational documents and other testimonials as per the checklist.
- (ii) The academic session will tentatively begin in the **third week of August 2026**.
- (iii) The hostel room allocation to the candidate will be done on a sharing basis. Hostel rooms for the DAP category candidates will be arranged on the ground floor (preferably).

Note:

- (i) The admission criteria for IPL Batch 06 (Session 2026-31) may be changed before the declaration of the results.
- (ii) The information in this document is applicable only for the admissions cycle IPL Batch 06 (session 2026-31).
- (iii) Any dispute concerning Admission for the IPL Batch 06 (Session 2026-31) would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Rohtak only.
- (iv) You will receive all admission offers in the form of a letter duly signed by the Controller of Examinations of IIM Rohtak, sent from ipladmission@iimrohtak.ac.in. Any offer received from any other email is completely invalid and is not official. All admissions to IIM Rohtak are provisional till you have completed all formalities upon reporting to the Institute.
- (v) If at any point of time it is found that the information provided by the candidate is false, incorrect, or misrepresented, the admission offer will stand cancelled.
- (vi) IIM Rohtak reserves the right to change, modify or adopt any new admissions process that it deems necessary at any point.

Refund Policy for IPL Batch 06 (Session 2026-31)

The last date for any withdrawal of provisional admission will be '**before the date of Registration (Online)**'. The entire fees received from the student, after deduction of the processing fee of ₹ 1000/- (one thousand only) will be refunded to the candidate by the mode of bank transfer to the candidate's own savings bank account provided by the candidate. The refund requests will be accepted only through the Institute's admission portal, i.e. <https://admission.iimrohtak.ac.in/SignIn/ipl-2026-31>

Refunds will be made automatically within 150-180 days from the date of registration of the programme. Please provide your own (i.e. candidate's) correct banking details (Beneficiary Name, Saving Bank Account Number, Bank Name, IFSC code) through the Institute's admission portal, i.e. <https://admission.iimrohtak.ac.in/SignIn/ipl-2026-31>

The Institute takes no responsibility in case the banking details provided by you are erroneous. Refund request(s) received from any other mode apart from the above-mentioned Institute's admission result portal will not be considered under any circumstances. Refund requests will not be entertained after the registration to the programme.

Total no. of seats:

The total number of seats for the IPL Batch 06 (Session 2026-31) will be **120**. The offer of admission to the candidate will be made strictly based on merit/rank list and availability of seats in each category (Gen, SC, ST, NC-OBC, EWS & DAP) as per the reservation rules of the Government of India.
